# **Industrial Park Lots Policy**

The City of Green Isle has acquired lots for the purpose of economic development. The intention of this policy is to set the price of lots in the industrial park at \$1 per lot. The goal of the City of Green Isle is to increase the tax base for the City. It is the purpose of this policy to outline the terms and conditions of the sale of lots.

- 1. Sale of lots will be approved by the Green Isle City Council.
- 2. Lots in the Industrial Park will be sold for \$1 per lot.
- 3. Closing will occur within 4 months of signing the purchase agreement.
- 4. If construction is not started within 180 days of closing, the lot is returned to the City of Green Isle.
- 5. A Development Agreement must be approved by City Council and both parties must adhere to the terms of the agreement.
