

ORDINANCE NO. 25

An Ordinance relating to the removal of snow, ice, dirt and rubbish from sidewalks within the village of Green Isle in Sibley county, Minnesota.

THE VILLAGE COUNCIL OF THE VILLAGE OF GREEN ISLE, MINNESOTA DO ORDAIN AS FOLLOWS:

Section 1. All persons occupying any building or ground within said village of Green Isle, and all persons owning any building or ground there-in shall remove or cause to be removed all snow, ice, dirt or rubbish from the sidewalk or sidewalks adjacent to and fronting upon any building or ground so owned or occupied by them, and shall permit no snow, ice, dirt or rubbish to accumulate thereon.

Section 2. It shall be the duty of the Village Marshall to see that the provisions of the foregoing section are not violated and to enforce the provisions of this ordinance, and on the failure or neglect of any owner or occupant aforesaid to remove or cause to be removed all snow, ice, dirt or rubbish which might have accumulated on any such sidewalk, the Village Marshall shall notify such owner or occupant or both of them to remove such snow, ice, dirt or rubbish from such sidewalk within Six hours from receipt of such notice.

Section 3. Should any owner or occupant neglect to remove or cause to be removed any snow, ice, dirt or rubbish which might have accumulated on any such sidewalk after having received notice to remove same, within the time specified in such notice, said Village Marshall shall forthwith remove or cause to be removed such snow, ice, dirt or rubbish from such sidewalk at the expense of such owner or occupant. On failure or refusal of any such owner or occupant to pay such expense on demand made by said village marshall, said village shall have a valid claim against such owner or occupant for the amount of such expense, which may be recovered by a civil action, and such claim shall be a lien on the real estate fronting on such sidewalk.

Section 4. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 5. This ordinance shall take effect and be in force from and after its passage and publication.

ORDINANCE NO. 26

An Ordinance to prohibit chickens, ducks, geese and turkeys from running at large at any time, in the village of Green Isle, Sibley County Minnesota.

THE VILLAGE COUNCIL OF THE VILLAGE OF GREEN ISLE, MINNESOTA DO ORDAIN AS FOLLOWS:

Section 1. All persons owning or possessing, chickens, ducks, geese or turkeys, are hereby prohibited from allowing same to run at large on the streets and alleys or from trespassing

upon the premises of others within the corporate limits of said village of Green Isle at any time during the year.

Section 2. Any person violating any of the provisions of this ordinance shall upon conviction thereof be punished by a fine of not less than five dollars (\$5.00) nor more than twenty-five (\$25.00) and the costs of prosecution.

Section 3. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 4. This ordinance shall be in force and take effect from and after its passage and publication.
