- 2. Pledge of Allegiance All stood for the Pledge of Allegiance.
- 3. Approve/deny April 5, 2022 Agenda Motion by Miller to approve the April 5 agenda, seconded by Brown. Motion carried.
- 4. Approve/deny March 1, 2022 Minutes Motion by Schuft to approve the March 1 minutes, seconded by Wentzlaff. Motion carried.

6. Monthly Reports/Updates:

Mayor's Report – Kreger reported that building continues and that there will not be a lot of lots left by the end of the year. Channel 9 will be coming to Green Isle for Town Ball Days on July 13th. It will be a big community event. Admission will not be charged for the game.

Council Liaison Report:

Mark Wentzlaff – Wentzlaff reported that the Council is still moving forward with the compost site, no news yet on the grant. For now the City will reopen the former site.

Diane Brown – Brown reported that the Easter Egg Hunt will be held April 16th at the GICS. Parks committee is considering a location for pickleball and an archery range.

7. Old Business:

- A) City website continuing to move forward with new city logo and website. Piotter will need to be asked to clean up the old website before data is transferred over.

Closed Meeting – to consider the sale of EDA owned lots: 34.0158.050, 34.0158.060, 34.0158.070 Motion by Schuft to end the closed session and reopen the regular meeting at 8:35 pm, seconded by Miller. Motion carried.		
	Consensus of the EDA to request Horstman to return to an EDA meeting with more information regarding his plans for 3 buildings on the lot. The EDA would like to consider cutting those lots into smaller 1-1.5-acre parcels.		
	Motion by Brown to offer to sell 34.0158.060 and 34.0158.070 for \$70,000 each or \$40,000 for 1.5 acres with the City of Green Isle paying to replat the lots, with a minimum lot value of \$500,000, seconded by Schuft. Motion carried.		
11.	Board and Director Comments – Newsom met with the Club New Yorker owner and provided loan paperwork, the owner plans to add a kitchen. GI EDA does not have enough RLF funds for the Club New Yorker project. They are looing for approximately \$40,000, Newsom provided them with a Sibley County RLF application.		
	Brown reported that Dan Dauffenbach will be honored at the GICS Elders Day on May 26 th . Newsom reported hearing some negative feedback regarding the GICS from members of Leading Sibley Together after they toured the school. Newsom and Schuft to schedule a time to tour the GICS.

2. Pledge of Allegiance – All stood for the Pledge of Allegiance.

3. Old Business:

A) Discussion with Justin Horstman regarding the sale of lot 34.0158.050 Horstman discussed his plans to put 3 buildings on the lot.

Option #1

The EDA is proposing to sell you the whole parcel 34.0158.050 for \$49,900 with the following conditions:

Put 3 buildings on the land all at least 60x90 with 24x24 offices.

1st building up in year 1.

2nd building in year 2. Subdivide (replat) the parcel into 3 separate parcels in year 2 before starting construction on building 2.

3rd building in year 3. If you do not finish buildings 2 or 3 those parcels would come back to the City. Each building on its own separate parcel.

Total of 5 FTE's in each building.

No tax abatement or TIF.

Option #2

The City will split that lot into 3 parcels and pay to replat. EDA would offer to sell you a smaller 1/3 size parcel for \$15,000 and give you right of first refusal on the next 2 parcels with a development agreement. Same idea, separate buildings on each tax id.

No tax abatement or TIF.

B) Discussion with John Behnke regarding price of industrial park lots. – Behnke did not attend the meeting. Consensus of the EDA to offer the lots at the asking price of \$49,900. EDA would like to consider replating the industrial park lots into smaller lots.

4.	Board and Director Comments — EDA recommends to Council that the Zoning Ordinance be changed to require that commercial buildings are required to have frost footings around the entire building perimeter.
