A) Discussion on Tax Abatement for 34.0158.090 (JIT Property)- Buyer Mark Miller was present to explain the need for tax abatement. EDA would like to see 3 employees by the end of year 1, city abatement shall be 100% in years 2 and 2, 60% in year 3, 40% in year 4, and 20% in year 5. Miller will also be required to move JIT Norwood

- to Green Isle. TK Metal Finishing will be coming to the Green Ise location. Consensus of the EDA Board to direct Soeffker to work with Ehler's to move forward with the abatement process.
- B) Discussion on GICS Bond Discussion extending the GICS bond out to 2068 with \$5,000 per month payments. The finance committee met on November 2, with the school's financial advisor and is waiting on a list of the school's current debt. Consensus of the EDA to work with Ehler's to extend the bond, public hearing will be held at the Council level.
