1. Call to Order – Meeting was called to order at 7pm by Chair Harrison De Boer.

- 3. Approve Agenda

- 4. Approve the Minutes
 - March 18, 2025 Motion by Danielle De Boer to approve the minutes, seconded by Harrison De Boer. Motion carried. Schuft abstained.
- 5. New Business
 - a. Review/Discussion of Zoning Code living in a camper Discussion on request by resident to reside in a camper on their lot while their house is repaired. Motion by Danielle De Boer to send to Council for special approval to allow it within a reasonable timeframe. Motion carried. Sheets arrived at the meeting at 7:20 pm and provided more information on the situation. City has letter prepared to send to resident. City does not want to set a precedent for residents living in campers and trailers. Motion by Danielle De Boer to rescind her prior motion, seconded by Schuft. Motion carries. Harrison De Boer will look at other cities to see how they address this situation.

Review Zoning Ordinance for and land use regulations to ensure compliance with comprehensive plan committee to review Parks District language change to Public/Institutional (telecommunications tower and base)/consistency in height limits throughout. Soeffker cleaned up the existing Zoning Code and emailed out a Word document for committee to work off of.
